Subject: - Grant of Recognition to Salwan Junior School, A-Block, Naraina Vihar, Delhi-110028, without Aid under RTE Act 2009.

Sir,

With reference to your application on the above cited subject, I have been directed to inform you that the Corporation vide its **Resolution No. 415 date 30.03.2021** has granted recognition from class-I to V without aid under RTE Act 2009 to **Salwan Junior School, A-Block, Naraina Vihar, Delhi-110028** w.e.f. the date of Resolution on the following conditions:-

1. Orders/Instructions issued by the Education Department, North DMC and the provisions of Delhi School Education Act/Rules, 1973 shall have to be followed strictly and the documents/returns as per rule 180 thereof submitted regularly.
2. All the appointments/terminations of teachers will be made with the prior approval of the Department.
3. At the time of selection of teachers in school, DDE/ADE/School Inspector Concerned will be a member of Selection Board.
4. An amount equal to three months salary of the teachers shall remain deposited as a reserve fund in the joint Account of Management and the Director, Education North DMC.
5. The Manager will have to obtain No Objection Certificate from the Department before applying for recognition for Middle/Secondary Classes.
6. Guidelines/directions issued by the Hon'ble Supreme Court of India/High Court or any other Court with reference to transportation of school children shall have to be complied with meticulously.
7. The salary of the staff will be paid through RTGS/ECS.
8. The management will get their school inspected by the concerned Zonal DDE/ADE/S.I. at least once during the academic session.
9. DDE/ADE/S.I./Principal of the best school of the zone will be included in the Management Committee of the School.
10. The Principal of the school will attend the meetings called by the Zonal DDE/ADE/S.I. from time to time.
11. School shall have to admit children belonging to EWS & disadvantage group to the extent of at least 25% under free-ship quota at entry level as per notification No- 15(172) /DE/ Act/2010/ 69 dated 07/01/2011.
12. The right of children to free and Compulsory Education Act-2009 shall have to be followed strictly.
13. The school is bound to provide facilities to physically handicapped students as per orders of Delhi High Court.
14. The school is bound to maintain the reservation roster register for employees of the school.
15. If the school violates the Delhi School Education Act & Rules, 1973, the Director, Education is empowered to terminate the recognition of the School.
